MISS SALT RIVER PAGEANT COMMITTEE

Seeking (4) Community Member Representatives

Qualifications:

1. Chairperson and Vice-Chairperson must be enrolled members of the Salt River Pima-Maricopa Indian Community.
2. All remaining Committee members must be enrolled in a federally recognized tribe.
3. All members of the Miss Salt River Pageant Committee must submit to and successfully pass a background check and drug test, including random drug testing as conducted by the Salt River Pima-Maricopa Indian Community.
4. All members must possess a valid Arizona driver's license and maintain adequate automobile insurance as required by the State of Arizona and must be insurable under the risk management standards of the Salt River Pima-Maricopa Indian Community.

Duties:

The Miss Salt River Pageant Committee shall assist the reigning Jr. Miss Salt River and Miss Salt River in participating in events and in representing the Salt River Pima-Maricopa Indian Community. Such duties shall include:

1. Identify and schedule events for participation.
2. Chaperone, when available, Jr. Miss Salt River and Miss Salt River to local and out-of-state events.
3. Prepare and conduct active recruitment for the positions of Jr. Miss Salt River and Miss Salt River.
4. Actively recruit volunteers to participate in meetings and events.
5. Actively seek funding and scholarship resources.
6. Other duties necessary as a MSRP committee member.

Terms:

The Miss Salt River Pageant Committee members serve a 2-year term.

Meetings:

Attend monthly, regular, and special meetings as necessary.

Other:

Must be willing to help during pageant week.
Knowledge of the Pima and Maricopa cultures a plus.

Salt River Community Golf Enterprises Board

Seeking (1) Community Member Representative

Salt River Community Golf Enterprises (“SRCGE”) is an enterprise of the Salt River Pima-Maricopa Indian Community (the “Community” or “SRPMIC”), created by the SRPMIC Council to aide in the economic development of the Community. Its primary focus is to operate two eighteen hole golf courses at the Talking Stick Golf Club that are under the management of the Troon, LLC.

Applications are being accepted for one (1) **Salt River Community Member Representative** to serve on the seven-member SRCGE Board. If appointed, the Board Member will serve a three-year term. Knowledge of development and operation of golf facilities, commercial real estate, financial services, land planning and the hospitality industry is highly preferred. Previous experience on an SRPMIC enterprise Board would also be valuable.

All SRCGE Board members are subject to a background check, reviewed for any possible conflict of interest, and must sign a Confidentiality Agreement and a Conflict of Interest Statement. Board members must be willing and able to attend regularly scheduled meetings and special meetings if needed, and will receive a stipend for regular and committee meetings, as well as for special meetings.

GAMING ENTERPRISES BOARD

(1) Community Member Representative

The Gaming Enterprises Board is responsible for adopting policies and procedures, approving budgets and reviewing the business results of the division of gaming.

Candidates must be willing to:

- Serve a 2-year term.
- Attend regular board meetings held on the last Tuesday of each month at 4:30 p.m.
- Attend special board meetings held on the second Tuesday of each month at 4:30 p.m. There may also be other special board meetings called as necessary.
- Have knowledge of the Community’s vision.
- Members will receive a paid stipend for regular and special meetings.

Experience in the following areas is preferred for the Community Member Seat: Professional or management experience in gaming, restaurant, hotel, convention, resort operations, banking or finance.

PLEASE NOTE: The appointed applicant will be subject to an extensive background check in order to obtain the necessary gaming license.

The duty of the board is to manage the affairs of the Institution to carry out its purposes.
