PROGRAM OVERVIEW

SALT RIVER VOCATIONAL REHABILITATION (SRVR) IS A TRIBAL VOCATIONAL REHABILITATION PROGRAM SERVING ELIGIBLE NATIVE AMERICANS WITH DISABILITIES WHO WANT TO, AND ARE ABLE TO WORK, BUT MAY NEED SOME SUPPORT AND/OR SERVICES IN ORDER TO BE SUCCESSFUL.



SRVR

- PROVIDES CULTURALLY APPROPRIATE SUPPORTS AND SERVICES TO INDIVIDUALS WITH DISABILITIES IN ORDER TO ASSIST THEM IN ACHIEVING A POSITIVE EMPLOYMENT OUTCOME
- PROVIDES INDIVIDUALIZED PLANS FOR EMPLOYMENT BASED UPON THE SPECIFIC NEEDS OF EACH CONSUMER
- PROVIDES SERVICES AND SUPPORTS BASED ON AN EMPLOYMENT GOAL
- SUPPORTS CONSUMERS IN SEEKING, SECURING, RETAINING, OR REGAINING EMPLOYMENT

ELIGIBILITY REQUIREMENTS

1. HAVE A DOCUMENTED DISABILITY THAT CREATES AN IMPEDIMENT TO EMPLOYMENT*
2. ENROLLED MEMBER OF FEDERALLY RECOGNIZED TRIBE*
3. LIVE WITHIN THE SRPMIC BOUNDARIES*
4. BE AVAILABLE AND ABLE TO WORK
5. CAN BENEFIT FROM VR SERVICES IN TERMS OF EMPLOYMENT OUTCOME

*REQUIRES DOCUMENTATION
