

## **Inoperable Vehicle Removal Program**

To have your inoperable vehicle removed:

1. Fill out items 1 through 7 of the Vehicle Removal Permit Application.
2. Have the title and your tribal or state ID ready with the application.
3. If you **do not** have the title to the vehicle, obtain a duplicate title by completing the attached Title and Registration Application. Bring the application to an Arizona Motor Vehicle Division office. They will charge \$4 for the duplicate title.
4. Contact the Community Development Department's Environmental Protection & Natural Resources Division at **(480) 362-7500** and leave a message letting us know you would like an inoperable vehicle removed. We'll call you back and set an appointment to come to your residence to review the paperwork.
5. If the paperwork is considered complete, we'll take it from there!
