The Salt River Pima-Maricopa Indian Community offers an automatic pay plan that provides you the convenience of having your utility bill directly deducted from your quarterly Per Capita check at no cost to you; it's called Auto Deduction.

How does Auto Deduction work?

With Auto Deduction, your utility bill will be automatically deducted from your quarterly Per Capita check.

You will continue to receive your statement by mail. It will identify you as an Auto Deduction customer. Your payment will be deducted from your Per Capita check before it is distributed to you.

How will Auto Deduction benefit me?


Becoming an AutoPay customer means you have one less check to write each month or one less trip to make to pay your utility bill; your account will be paid automatically. You will no longer need to be concerned with mailing or delivering your payment in person.

How will I know when my Auto Deduction has been set up?

Once your Auto Deduction has been set up, your statement will read Do Not Pay. This amount will be deducted from your Per Capita check quarterly. These messages will confirm that your Auto Deduction is active and you no longer need to send a payment.

May I discontinue Auto Deduction?

You can cancel your Auto Deduction authorization at any time by contacting the Finance Accounts Receivable Department at **(480) 362-7720**. Please allow for reasonable processing time.
