#### ANNUAL MAINTENANCE SUBMITTAL CHECKLIST

#### The following are required items that must be included with your submittal package:

- Permit Application
- Narrative describing type of maintenance permit that is needed
- EPNR Clearance Memo
- Site map/Vicinity map with street names showing ingress/egress points
- Traffic Control Plan if applicable
- Cultural Sensitivity Training for each and every individual who is on the job site or participating in any ground disturbance activities.
- SWPPP with NOI, if disturbing one acre or more.

Once all review activities are completed and approved, applicants will receive an email notification that the permit is ready to be issued. Before permit issuance, Contractor must also have a current SRPMIC Business license.

### WHAT IS CST?

Cultural Sensitivity Training (CST) educates consultants, contractors and other "ground disturbing" workers about cultural artifacts they may encounter and their significance to the modern day O'odham and Piipaash.

During this education process you will learn how Community and Federal laws and ordinances protect sacred sites and artifacts. You will also become familiar with the Request for Environmental Review process.

### WHO NEEDS TO TAKE CST?

Everyone involved in construction-related activities in the Community, including contractors, subcontractors (regardless of trade or specialty) and their on-site employees.

Any worker involved in ground-disturbing activities on the Community.

## CAN YOU WORK ON THE COMMUNITY WITHOUT IT?

No, you have to take the class before commencing any work on SRPMIC Community land.

Any illegal activities pertaining to archaeological sites or any persons violating the provisions of tribal ordinances or federal laws can be fined and prosecuted pursuant to The Native American Graves Protection and Repatriation Act (NAGPRA).

WHAT ARE THE CULTURAL FEES AND HOW ARE THEY CALCULATED?

Cultural Resource Fees are 1% of Building Permit Fees or \$10, whichever is greater. Residential Permits, Deferred Submittals, Plan Review fees or Revisions to previously approved permits are excluded from these fees. Fees are collected by the Engineering and Construction Services Department Compliance Division prior to the issuance of a permit.
