



Reporting Flu Shot in MyWellPath



Step-by-Step instructions on how to report your flu shot in MyWellPath

- 1 Access MyWellpath from the Wellpath website:
www.srpmic-nsn.gov/wellpath/mywellpath/
- 2 You will land on the MyWellPath login screen.
- 3 Enter your Username and Password to Login. Click on First Time User to set up your account if you have not yet create a MyWellPath account. You can view the Register for an Account Guide at www.srpmic-nsn.gov/wellpath/mywellpath/ to get you started.
- 4 Once you have entered your account credentials, you will be redirected to your Home Page. To log your flu vaccine, click on Activity in the navigation menu on your MyWellPath Home Page. A pull-down menu will appear. Click on Log Activity, which will redirect you to the Log Activity screen.
