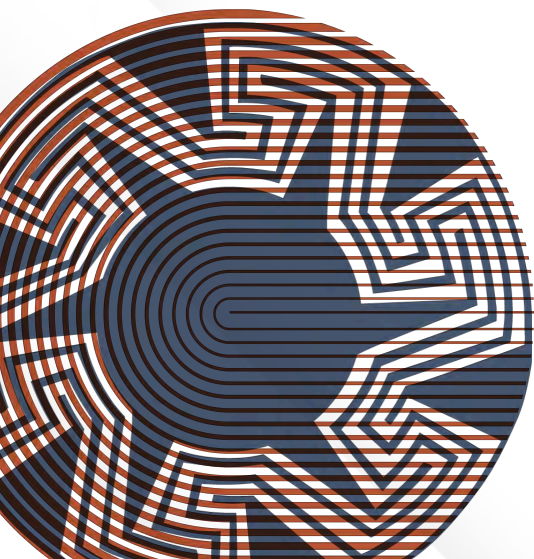

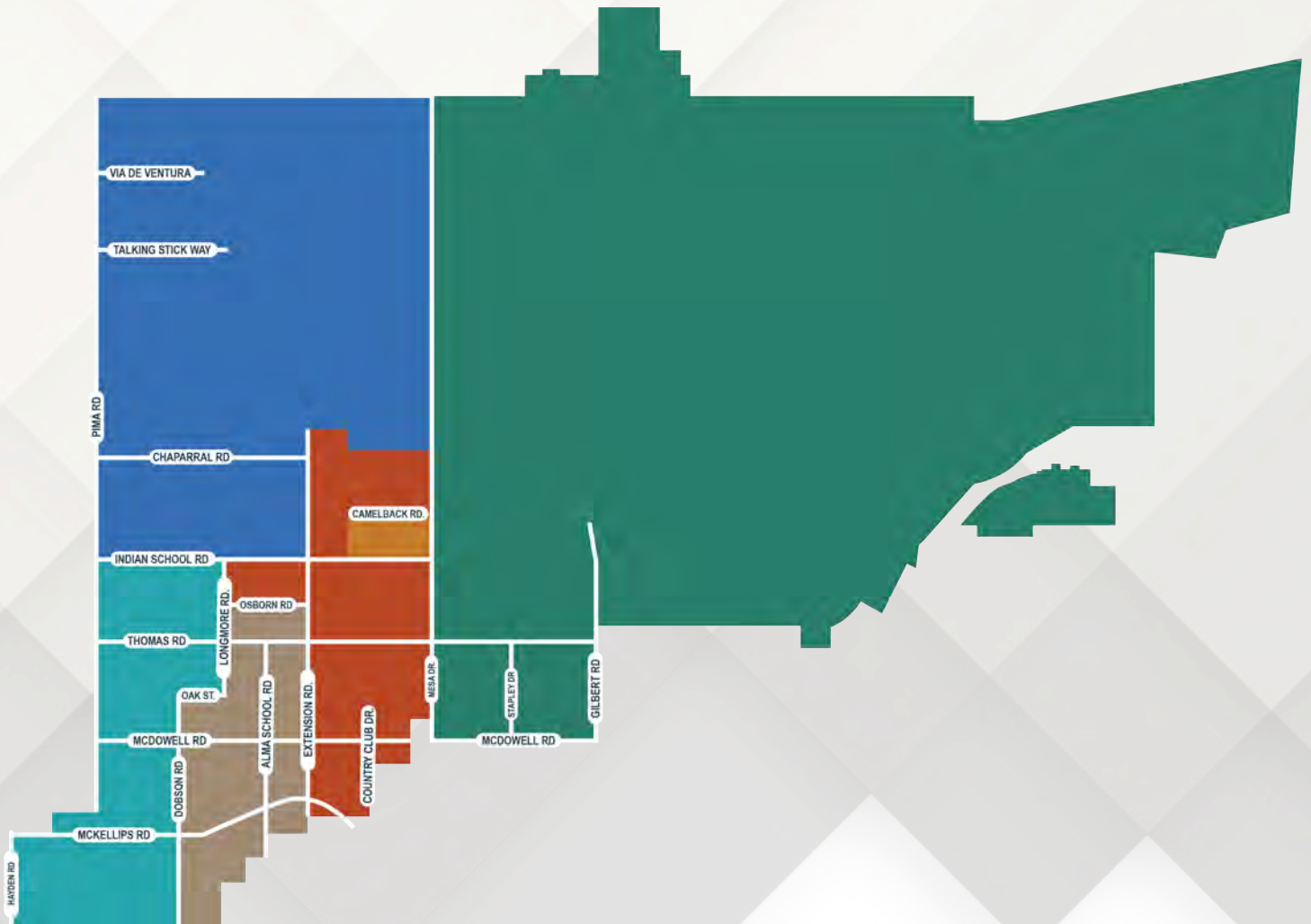

MEMORIAL & CEMETERY SERVICES

When enrolled SRPMIC members experience a death in the family, **the FIRST STEP is to reach out to the Salt River Memorial Hall before making any preparations.** The Memorial Services staff is here to guide and assist you through the process.

The Salt River Memorial Services and Cemetery staff assist community member families preparing for services and the burial of loved ones. Burial assistance is provided to all enrolled members living on or **off** the SRPMIC.

The cost of a casket, burial, and/or cremation, and services are paid for by the Community up to \$3,370 (casket burial) or \$3,480 (cremation); payments are sent directly to the mortuary. Mortuary Services include removal and transport to the funeral home, transport to the wake and/or funeral service, embalming, casket or cremation preparation, casket or urn, memorial book, and memorial cards.

FUNERAL ASSISTANCE LOAN

The SRPMIC Funeral Assistance Program is a coordinated effort between the Administration and Public Works departments to provide financial assistance and resources for funerals for those in the family circle, as defined in the policy. Funeral loans (from per capita payments) are available, up to \$500.

Attendance Officers monitor school attendance and implement interventions in order to deter truancy. SCR specifically addresses underlying issues related to inconsistent school attendance, behavioral concerns and provides educational financial assistance.

The Salt River Higher Education Program provides financial aid, scholarship, recruitment, retention, and advising services to community members through community college, university, or vocational studies.

Currently, the Higher Education Program pays tuition for academic college/universities that is equal to or lesser than the maximum Arizona rate or the rate of Arizona State University, Northern Arizona University, or the University of Arizona or any of the Maricopa Community Colleges rates, plus 75% of the remaining base tuition balance at the student's institution of choice.

Tuition example for Out-of-State School (per semester):

- Out-of-State Tuition Rate = \$26,381.50
- Max Arizona Tuition Rate = \$5,700
- Balance = \$20,681.50
- Additional 75% of the balance covered by Higher Education = \$15,511.13
- Total covered by Higher Education = \$21,211.13
- Total out-of-pocket costs covered by the student = \$5,170.37

The Adult Deferred Per Capita Program is voluntary and optional, but individuals must affirmatively make an election in writing to participate. The Program provides community members with a voluntary option to defer, save, and invest per capita payments and Minor Trust distributions on a tax-deferred basis, which allows individuals to defer their quarterly per capita payments and Minor's Trust money until a future date. The money deferred will not be taxed now; taxes owed will be deferred until the money is received.

A new community wellness program specifically for enrolled members of the Salt River Pima-Maricopa Indian Community and their immediate family members. Activities include Family, social/Cultural, emotional/Spiritual, physical, and Financial Wellness.

How Does StrongLife Work?

Participants earn points through 5 wellness theme activities. Each theme is worth 100 points, with the exception of physical wellness, which is worth 150 points due to more opportunities to participate actively. Strong Life participants earn points with a cash value of up to \$550 per calendar year for working activities in each theme.
